- The Republic of Tajikistan has received additional financing from the Asian Development Bank (ADB) toward the cost of **Dushanbe Water Supply and Sanitation Project**, and it intends to apply part of the proceeds of this financing to payments under the contracts named above. Bidding is open to Bidders from eligible source countries of ADB.

As a minimum, the Bidder's net worth for the last year, calculated as the difference between total assets and total liabilities should be positive.
