- 1. The Republic of Tajikistan has received financing from the Asian Development Bank (ADB) toward the cost of **Additional Financing for Dushanbe Water Supply and Sanitation Project**. Part of this financing will be used for payments under the Contract named above. Bidding is open to Bidders from eligible source countries of ADB.
- 2. The State Unitary Enterprise (SUE) Dushanbevodokanal (DVK) ("the Employer") invites sealed bids from eligible Bidders for the construction and completion of Rehabilitation of the South Sewage Collector: Sections from K1 to K56 ("the Works").
- 3. **Open competitive bidding National advertisement** will be conducted in accordance with ADB's <u>Single-Stage</u>: <u>One-Envelope</u> procedure and is open to all Bidders from eligible countries as described in the Bidding Document.
- 4. Only eligible Bidders with the following key qualifications defined in the Bidding Document may participate in this bidding:

Historical Financial Performance	Submission of audited financial statements or, if not required by the law of the Bidder's country, other financial statements acceptable to the Employer, for the last three (3) years (2022, 2023, 2024) to demonstrate the current soundness of the Bidder's financial position. As a minimum, the Bidder's net worth for the last year, calculated as the difference between total assets and total liabilities should be positive.
Average Annual Construction Turnover	Minimum average annual construction turnover of US Dollars Five Million (US\$ 5,000,000); calculated as total certified payments received for contracts in progress or completed, within the last three (3) years.
Financial	For Single Entities:
Resources	The Bidder must demonstrate that its financial resources defined in FIN - 3, less its financial obligations for its current contract commitments defined in FIN - 4, meet or exceed the total requirement for the subject Contract of US Dollars Seven Hundred and Fifty Thousand (US\$ 750,000.00);

	For Joint Ventures: One partner's financial resource defined in FIN-3, less its financial obligations for its current contract commitments defined in FIN - 4, must meet or exceed its required share of 40% (US\$ 300,000.00) from the total requirement for the subject Contract. Each partner's financial resources defined in FIN-3, less its financial obligations for its current contract commitments defined in FIN - 4, must meet or exceed its required share of 25% (US\$ 187,500.00) from the total requirement for the subject Contract. The combined financial resources of the Joint Venture must meet or exceed US\$ 750,000.00. Details are provided in Section 3 of the Bidding Document.
Contracts of Similar Size and Nature	Participation as a contractor, Joint Venture partner, or Subcontractor, in at least one contract that has been satisfactorily and substantially completed within the last five (5) years and that is similar to the proposed works, where the value of the Bidder's participation exceeds US Dollars Two Million Six Hundred Thousand (US\$ 2,400,000.00). The similarity of the Bidder's participation shall be based on the physical size, nature of works, complexity, methods, technology or other characteristics as described in Section 6 (Employer's Requirements).
Experience in Key Activities	 For the above or other contracts executed during the period stipulated in 2.4.1, a minimum construction experience is required in the following key activities: 1. Installation of minimum 3 km sewer pipes with a diameter of DN 500 mm, till DN 1200 mm. 2. Road rehabilitation civil works. Minimum 3 kms of pavement and asphalt roads 3. Experience in construction of works on subsidence soils. Experience in construction of reinforced concrete wells in subsiding soils.
