1. The Republic of Tajikistan has received financing from the Asian Development Bank (ADB) toward the cost of Resilient Livelihoods and Empowerment of Rural Women Project, and it intends to apply part of the proceeds of this financing to payments under the contract named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The Project Implementation Group under the Ministry of Agriculture of the Republic of Tajikistan (“the Purchaser”) invites sealed bids from eligible Bidders for the supply of Beekeeping professional packages and Wooden beehives for diversification in apiculture for intensive homestead plots.
3. Open competitive bidding will be conducted in accordance with ADB’s **Single-Stage: One-Envelope** procedure and is open to all Bidders from eligible countries as described in the Bidding Document.
4. Only eligible Bidders with the following key qualifications defined in the Bidding Document may participate in this bidding:
 - Successful completion as main supplier within the last three (3) years, of at least two (2) contracts for each valued at \$890,000 (eight hundred ninety thousand) with nature, and complexity similar to the scope of supply described in Section 6 (Schedule of Supply);
 - Submission of audited financial statements or, if not required by the law of the Bidder’s country, other financial statements acceptable to the Purchaser, for the last three (3) years (2022, 2023 and 2024) to demonstrate the current soundness of the Bidder’s financial position. As a minimum, the Bidder’s net worth for the last year calculated as the difference between total assets and total liabilities should be positive; and
 - Minimum average annual turnover of \$1,670,000 calculated as total payments received by the Bidder for contracts completed or under execution over the last three (3) years.
