1. The Republic of Tajikistan has received financing from the Asian Development Bank (ADB) toward the cost of the Resilient Livelihoods and Empowerment of Rural Women Project, and it intends to apply part of the proceeds of this financing to payments under the contract named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The Ministry of Agriculture of the Republic of Tajikistan (“the Purchaser”) invites sealed bids from eligible Bidders for the supply, installation, and commissioning of goods. The contract is to be delivered in 6 months and includes supply and installation of Heated and non-heated metal-framed plastic greenhouse.
3. Open competitive bidding will be conducted in accordance with ADB’s **Single stage/One Envelope** procedure and is open to all Bidders from eligible countries as described in the Bidding Document.
4. Only eligible Bidders with the following key qualifications defined in the Bidding Document may participate in this bidding:

Successful completion as main supplier within the last three (3) years, of at least two (2) contracts each valued at **\$1,040,000.00** (One million forty thousand USD) with nature, and complexity similar to the scope of supply.

The Bidder must demonstrate the soundness of its financial position. As a minimum, the Bidder’s net worth for the last year calculated as the difference between total assets and total liabilities should be positive.

The Bidder must have a minimum average annual turnover of **\$1,950,000.00** (one million nine hundred fifty thousand USD) calculated as total payments received by the Bidder for contracts completed or under execution over the last three (3) years.
