The Republic of Tajikistan has received financing from the Asian Development Bank (ADB) toward the cost of the Resilient Livelihoods and Empowerment of Rural Women Project, and it intends to apply part of the proceeds of this financing to payments under the contract named above. Bidding is open to Bidders from ADB's eligible source countries.
2. The Project Implementation Group under the Ministry of Agriculture of the Republic of Tajikistan ("the Purchaser") invites sealed bids from eligible Bidders for **Rehabilitation of an existing government-owned building to serve as a women's center/shelter** ("the Works").
The rehabilitation works under this Contract will include the full scope of construction, rehabilitation, engineering, installation, commissioning, and all associated activities required for the completion of the reconstruction of the premises of the Regional Women's Support Center, a two-floor building, located at str. Valizoda 3, Bokhtar City, Khatlon Region, Republic of Tajikistan. All reconstruction and rehabilitation works will be carried out in accordance with the advance-prepared architectural, structural, engineering, and technical design documentation.
3. Open competitive bidding – National advertisement will be conducted in accordance with ADB's [Single-Stage: One-Envelope Bidding Procedure](#) and is open to all Bidders from eligible countries as described in the Bidding Document.
4. Only eligible Bidders with the following key qualifications defined in the Bidding Document may participate in this bidding:
 - Historical Financial Performance: Submission of audited financial statements or, if not required by the law of the Bidder's country, other financial statements acceptable to the Employer, for the last **3 (three) years** to demonstrate the current soundness of the Bidder's financial position.
 - Average Annual Construction Turnover: Minimum average annual construction turnover of **TJS 7,400,000** calculated as total certified payments received for contracts in progress or completed, within the last **3 (three) years**.
 - Contracts of Similar Size and Nature: The bidder shall submit evidence confirming substantially or

Two (2) similar contracts for works of nature and complexity equivalent to the Works with contract value of not less than **TJS 1,850,000** each within the last **five (5) years** prior to the bid submission date. To comply with this requirement, works cited should be completed or substantially completed. The contract must be comparable in nature and scope to the proposed works.
